They supplied and installed Multi channel Hybrid planetarium with 6no. of JVC projectors to Nehru Planetarium New Delhi in 2010. On technical ground this installation is not a historical installation because technically there is no major change in system architecture and system integration from 2010 and 2023. We agree that there is a tremendous advancement taken place in projector technology, software database etc. in the last 5 years. You are aware that all the planetarium OEM's are basically system integrators and developer of Driving engine. They always use the latest projectors and servers in integrating of their system and upgrade their previous installations with updated software and technology. The same was also done by Sky-Skan in Nehru planetarium in 2018. Hence, technically the installation must be judged with its system architecture, integration technology and software updatation but not by the year of installation i.e. 2010 or 2013 or 2023. Therefore, We request you to consider our request and allow our Nehru Planetarium New Delhi installation done in October 2010.</p>	<p>NO CHANGE in the Clause</p>
